

CONTROLLER OF YOUR PERSONAL DATA

Your personal data will be used by CIHEAM Zaragoza located at Zaragoza, Av. Montañana 1005. NIF N0011376A.

This means that personal data collected by the General Secretariat or an institute is the responsibility not only of the body receiving the data, but of the CIHEAM as a whole. WHAT DATA WILL WE USE?

We will use the following personal data:

PURPOSE AND LEGAL BASIS FOR DATA PROCESSING

DATA RECIPIENTS

Without prejudice to communications made in compliance with the legal and contractual obligations, your personal data are not subject to any form of dissemination and are processed exclusively for the purposes specified above only by employees and/or

collaborators of the Data Controller in their capacity as persons assigned data processing tasks and/or internal processors, and by external processors authorized to process the data on behalf of the Data Controller. DATA STORAGE PERIOD

Data collected by CIHEAM Zaragoza will be stored for the time required to fulfil the objective in question and subsequently to fulfil the legal requirements and for administrative purposes.

WHAT ARE YOUR RIGHTS WHEN YOU PROVIDE US WITH YOUR DATA?

As data subject, you have the following rights:

- You may request access, rectification, erasure, appeal or object to the processing of your data;
- You may obtain-without hindrance from the data controller-your data in a structured, commonly used and machine-readable format for transmission to another data controller;
- You may revoke your consent to the processing of your data, without prejudice to the lawfulness of the processing based on consent given prior to the revocation.
